The Fairfield Glade Police Department's administration front desk has officially moved to its new location at 5160 Peavine Road here in Fairfield Glade. Glade Police Department is open Monday through Friday 8:00 AM to 4:00 PM. Their phone number for non-emergency situations is still 931-484-3785. Residents are still reminded to call 911 for emergencies.

New as of July 1, 2018

There are several new laws that took place as of July 1, 2018. Among the ones that may be of special interest to you are:

SB1670-"Pharmacy and Pharmacists: authorize a pharmacist in this state to dispense, in good faith, to a patient without proper authorization or a valid prescription the number of dosages of a prescription drug necessary to allow the patient to secure proper authorization or a valid prescription from the patient's prescriber; limits the amount of a prescription drug dispensed under this amendment to a 20-day supply."

SB0912-Driver Licenses: "allows a victim of identity theft to apply for and receive a new driver license with a new distinguishing number upon presenting proof of the crime, including a law enforcement report that lists the applicant as a victim of identify theft; allows the department of safety to charge a reasonable fee for reissuance of a drive license

due to identity theft."

HB2024-Criminal Procedure: "revises and makes permanent and applicable statewide the Knox County pilot project that allows indigent criminal defendants to pay their court costs and litigation taxes through the performance of public service."

HB1883-Controlled Substances: "clarifies that the present law

that exempts certain oils containing cannabidiol and used for research or treatment of seizures or epilepsy will not be repealed on June 30, 2018.

There are over a dozen new laws effective July 1 in Tennessee, but these might be more relevant to you than the others.

Bears in our Neighborhoods

Although bears can be cute, they can also be dangerous. This little guy's picture taken from a neighbor's house is just one example of bears that are around. Keep yourself and your pets safe by following the recommendations of Bearwise:





THE SIX BEARWISE BASICS



NEVER FEED OR APPROACH BEARS

Feeding bears (intentionally or unintentionally) trains them to approach homes and people for more food. Bears will defend themselves if a person gets too close, so don't risk your safety and theirs!



SECURE FOOD, GARBAGE AND RECYCLING

Food and food odors attract bears so don't reward them with easily available food or garbage.



REMOVE BIRD FEEDERS WHEN BEARS ARE ACTIVE

Birdseed and other grains have a high calorie content making them very attractive to bears. The best way to avoid conflicts with bears is to remove feeders.



NEVER LEAVE PET FOOD OUT

Feed outdoor pets portion sizes that will be completely eaten during each meal and then remove leftover food and food bowl. Securely store these foods so nothing is available to bears.



CLEAN AND STORE GRILLS

After you use an outdoor grill, clean it thoroughly and make sure that all grease and fat is removed. Store cleaned grills and smokers in a secure area that keeps bears out..



LET NEIGHBORS KNOW

Share news with your friends and neighbors about recent bear activity and how to avoid bear conflicts. Bears have adapted to living near people; are you willing to adapt to living near bears?

Current Tennessee Elections

Early voting began July 13 and will continue until July 28, 2018. The regular election for people not taking advantage of early voting will be August 2. Early voting takes place at 2 South Main Street, Crossville. Inperson voting on August 2 takes place at your regular polls. What are individuals casting their votes on? There are two **State Primaries**, one for Republicans and the other for De-

mocrats. The particular offices include governor, US Senate, US House of Representatives District 6, TN Senate District 15, TN House of Representatives District 25, State Executive Committeeman District 15 and State Executive Committeewoman District 15. There will also be County General Elections where people will cast their vote for County Mayor, 2 County Commissioners for Dis-

tricts 1 through 9, County Trustee, Sheriff, Circuit Court Clerk, Register of Deeds, Road Superintendent, and School Board Districts 1, 3, 5, 7, and 9.

Exercise your right to vote. Remember to bring an official ID, even if expired including:

- Tennessee driver license with picture

- **United States Passport**
- Photo ID issued by the Tennessee Department of Safety and Homeland Security
- Photo ID issued by the federal or Tennessee state government
- United States Military photo ID
- Tennessee handgun carry permit with your photo
