September 13, 2023

The meeting was called to order at 8:00AM by John Lannamann (Vice Chair).

1. **Welcome and Introductions** – John welcomed and thanked everyone for attending the September 13, 2023 Board Meeting.
2. **Fairfield Glade Police Department Update (FGPD)** – Capt Rosser stated the Police Department has been extremely busy. Final interviews for the CALEA recertification took place and we believe they went very well. In November, Chief Self and Detective Dagley will be attending a conference in Washington for presentation of the re-accreditation.

The Scam class was well attended. Bitcoin scams continue to be an issue with a recent scam of over \$80,000. The scammers have an answer for everything and if a person is lonely, the scammer will take advantage of that and will talk that person into giving up money. A new scam that seems to be working its way into Fairfield Glade and the Knoxville area is a realtor scam on TikTok. Capt Rosser has received information on these get rich quick scams of trying to take over property with a quit claim deed.

Speeding tickets are up with 241 written to-date compared to 138 last year. Assist the County calls are up considerably. (See the attached report for the entire list)

Resident Scott Hageny spoke to the group and expressed his frustration over speeding and trucks carrying unsecured loads on Westchester Road and the other main roads in Fairfield Glade. Capt Rosser and Dave Stout reassured Scott that they are aware of the issue and they are working on it. They pointed out the increase of speeding tickets that have been written. With a limited number of officers covering 26 square miles, the FGPD are doing the best they can. Speeding is not the only issue in Fairfield Glade and with nearly 10,000 residents, the officers on duty are doing their best to cover the entire area. Stonehenge, Catoosa, St. George, Westchester, Forest View and Peavine Road are the largest complaint areas.

3. **Fairfield Glade Fire Department Update (FGFD)** – Vince reported there were 16 calls in August. Year to date there have been 111 calls which compares to 111 this time last year. Fire calls this year stand at 3 where last year we had 14. EMS calls are at 26 compared to 45 last year. It is great to see that both fire and EMS calls are down considerably this year. False alarms have increased significantly with 35 this year compared to 21 last year. Many are due to malfunction of fire and smoke alarms. There have been 5 weather related calls with 3 being in one day. Fortunately, over the past 18 months we have only had 2 serious structure fires.

The FG Fire Department will be having a Concert and Dance fundraiser on November 10th from 6:00pm to 8:00pm at the Center. The cost is \$20 per person and tickets are available at the Center. The Labor Day weekend Pancake Breakfast was well attended with over 1200 people and raised approximately \$14,000.

4. **Approval of Minutes** – Dave made a motion to approve the August 9, 2023 Board Meeting minutes; Susan seconded and the motion carried.

5. **Fairfield Glade Resident Services (FGRS)** – Bob Willis reminded everyone their golf tournament will be this Sunday at Dorchester. Bob said they are looking for new Board members as they have had a few resignations recently. FGRS has done a lot of work on their strategic plan by looking at what they are doing, what they can do better, and what they can add to benefit residents. At this time FGRS is analyzing the data from their recent survey and focus groups. Dave suggested having a veterans group reach out to other veterans. Bob welcomed the idea and will present it to the FGRS board.

6. **Treasurer's Report** – Phyllis advised the only change to the checking account this month was a \$4 donation at the Safety Day/Shredder truck event. Capt Rosser suggested we have a shredder truck on the day the FGPD hold their Scam seminar. A comment was made that the traffic flow for the shredder truck moved better than in April. Susan commented CarFit was a great program and is a way for residents to have their car's head and tail lights, directional signals and tires checked to ensure they are working properly.

7. **Membership** – Cyd spoke by phone and updated the group on the FGNWC Annual Meeting and Coordinators event in October. She has received responses from approximately 50% of the coordinators. The meeting will begin at 9:00 with set-up beginning at 8:00. Speakers will be Cumberland County Sheriff Casey Cox, FGPD Chief Kate Self and Capt. Mark Rosser, and FGFD Chief Chris Young.

8. **Old Business** –

- Safety Day went well. FGRS and AARP distributed over 100 bags of information in the first hour of the event.
- Free Overdose Prevention Training – Capt. Rosser stated the event was well attended updating everyone on drug awareness and how to use Narcan. Unfortunately, heroin has made its way into our county and there have been some overdose deaths.
- Gun Safety Workshop – Capt Rosser does not have a firm date yet but is looking at some time in November. He was waiting for Tennessee politicians to make a decision on the Red Flag laws, but since they have not moved on anything, he will go ahead and schedule a date.
- Benches for the First Responders/Veterans Park – tabled until the November Board meeting. Coordinators at the FGNWC Annual Meeting in October may be polled on their thoughts of this project.

- Neighborhood Watch Signs – John provided an update on all posted signs in Fairfield Glade. He and Evelyne travelled all roads in Fairfield to verify their current locations. A total of 50 small signs and 3 large signs are permitted by ACC.

9. **New Business** –

- Chief Self stopped in to say FGPD is now partnering with CrimeStoppers. The Chief will be obtaining marketing information for distribution to residents. She will check to see if someone from CrimeStoppers can attend the FGNWC Annual Meeting in October to give a brief explanation of what they do.
- Chief Self mentioned she would like to hold a Coffee/Cider with Cops this fall, possibly in late October or early November.
- Web Site renewal was tabled until the November Board meeting.

The next Board meeting will be the Annual Meeting/Coordinators Appreciation Breakfast on October 11, 2023, 9:00AM, at the FG Police Department.

The meeting was adjourned at 9:37AM.

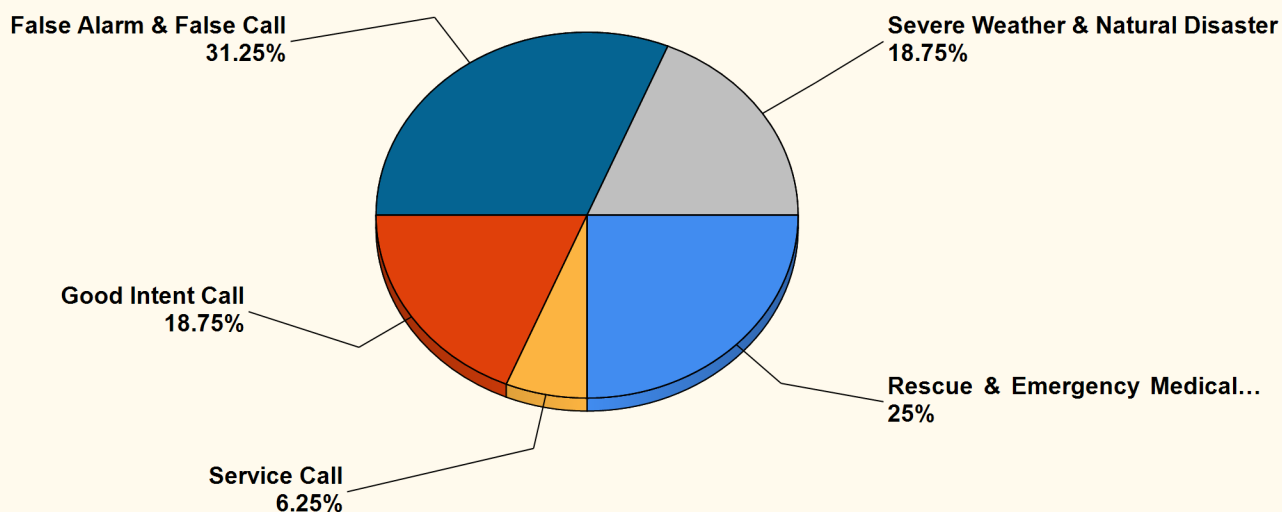
