

#### FGNWC Board of Directors Meeting

April 10, 2024

**Board Members in Attendance**: – John Lannamann – Chair, Jan Priest – Vice Chair, Phyllis Molnar – Secretary, Cyd Riede – Membership, Evelyne Kornreich – Projects, Susan Tebbe - Director-at-Large.

<u>Guests</u>: - Capt Mark Rosser and Chief Self - FGPD; Josephine Cassidy – FGFD; John Wedgworth – President FGRS; Carole Lannaman and Phyllis Betz – Coordinators.

Absent: Dave Stout– Law Enforcement.

The meeting was called to order at 8:00AM by John Lannamann (Chair).

1. <u>Welcome and Introductions</u> – John welcomed and thanked everyone for attending the April 10, 2024, Board Meeting.

2. **Fairfield Glade Police Department Update (FGPD)** – Capt Rosser updated the board members on the FGPD. Safety Day will be held this Saturday, April 13. The recent Scam presentation was very successful with approximately 60 people in attendance. Presenters were from TBI, sheriff's department, a cyber expert, a young lady discussing PayPal scams and the latest trends for young people, and Medicare scams. The homicide trial (shooting that took place in the Glade two years ago) is in its second day of trial. Due to personnel changes in the department, a date has not yet been determined for the Active Shooter Training. The TWRA will be holding a seminar on May 29<sup>th</sup> which will include boat and wildlife safety; details are being finalized. The recent shredder event went well and was busy for the full two hours.

3. <u>Fairfield Glade Fire Department Update (FGFD) –</u> Josephine advised the FGFD responded to six calls in the month of March (see the attached report). Year to date, FGFD has received 36 calls. Dates for this year's Pancake Breakfasts are May 25<sup>th</sup>, July 6<sup>th</sup>, and August 31<sup>st</sup>. On May 18<sup>th</sup> there will be a Racquet (Tennis and Pickleball) Fundraiser at the Racquet Center.

John Wedgworth said a new website for the FGFD was launched this week. He encourages everyone to visit the site.

4. **Approval of Minutes** – Cyd made a motion to approve the March 6, 2024, Board Meeting minutes; Evelyne seconded, and the motion carried.

5. **Fairfield Glade Resident Services (FGRS)** – John said they have tentatively scheduled May 6<sup>th</sup> 2:00 at the Center for a presentation by T.J.Williams on the 911 Center which would describe the process of how an individual's call to 911 is handled, from beginning to end. With nearly 1600 EMS calls in Fairfield Glade, it is

important for residents to understand what is involved when making a 911 call. FGRS is trying to finalize details with the Center but if the monetary cost of the room cannot be waived, the event will be cancelled.

Starting April 18<sup>th</sup> at the Village Green Maill, FGRS has organized a dedicated force of retired nurses who will provide a blood pressure clinic. This will be available every Thursday from 10:00 – 12:00. FGRS had an overwhelming response to their request and had to turn nurses away.

6. **<u>Treasurer's Report</u>** – Phyllis reported there were no changes to the bank account during the month.

7. <u>Membership</u> – - Cyd has had a few people showing interest in neighborhood watch. She has been contacting residents who stopped at the FGNWC table during the recent Community Fair Event and the Get Involved Expo. Some are residents inquiring if they are in a neighborhood watch group or asking how to organize their area.

#### 8. Old Business –

- Maps Cyd is working with SignWorks for the new dry-erase board map. However, the paper map of Fairfield Glade that we were going to use is copyrighted. Cyd and John will be meeting with Glade Realty to obtain their permission to update and use the map.
- Website Evelyne has had our webmaster, Jeff Wilson, update the board members, dates of the FGNWC board meetings and special events on our website. John W commented that including analytics to the site would be very beneficial to the board. It would give us information on what people are viewing on the site. John L will check on the possibility of FGNWC having an email blast by FGCC.
- Budget Evelyne has received the cost for the Village Green Mall for our annual bake sale, suggestions of possible donations to the FGPD and FGFD, etc.; the board will need to decide and vote on which projects to proceed with.
- Volunteer Expo and Community Information Fair Susan and John represented FGNWC at the events. It was suggested to have small items such as pens or candy available at the table to help entice people to stop for information. Evelyne will check on costs for pens with the FGNWC name, logo and website.

#### 9. New Business -

- Signs Cyd has ordered 15 small FGNWC signs and one large. Delivery will be approximately two weeks so Evelyne will prepare the location list for Bill Heidle to install.
- Bake sale Discussion took place on holding a bake sale this year. A vote was split on whether to hold a bake sale this year, so it is tabled until next month. A motion was made to earmark \$1000 for the FGPD, Phyllis seconded, and the motion passed. Capt Rosser mentioned trail cameras would be a nice purchase and would go directly toward neighborhood safety. He currently has cameras in various locations, and they are easily moved to other areas as needed. The other consideration is adding a speed gun.
- Publicizing FGNWC website Suggestions were made on additional ways to publicize our website. Everyone is asked to promote our website as much as possible.
- Tip sheets Evelyne provided a list of the tip sheets and mentioned a few that need updating. To get more exposure to the Tip Sheets, it is suggested we take one or two each month to highlight.

The next Board meeting will be held on May 8, 2024, 8:00AM, at the FG Police Department. FGNWC Board Meetings are open to all residents.

The meeting was adjourned at 9:21AM.




#### Fentress County Checkpoint on 3/15

Fentress County Sheriff's Office March 19 at 10:46AM · O

On 03/15/2024 The Fentress County Sheriff's Office, in conjunction with the Tennessee Highway Safety Office, conducted a scheduled sobriety check point. The check point was located at the intersection of Hwy 127 South York Hwy and Hwy 62 in Clarkrange. Agencies from across the State assisted. A total of 43 Law Enforcement Officers were on hand along with 2 D.R.E Agents (Trained Drug Recognition Experts) who are highly trained to recognize impairment in drivers under the influence of drugs. The purpose for the sobriety check point is to show that Law Enforcement is being proactive in trying to put a stop to drunk driving and impaired driving. Our goal is to keep the citizens of Fentress County and the State of Tennessee safe on our roadways and to make sure you are driving safely and buckled up. A total of 453 vehicles were checked. 14 Citations were issued along with 2 arrested for Driving under the influence and 1 drug related arrest.

A total of 10 Different agencies assisted and are as follows. 


